On January 10, 2022, the Acquiror acquired beneficial ownership of 40,540,013 Resulting Issuer Shares, as a result of the completion of the transaction (the “**Transaction**”) between the Resulting Issuer (formerly Valdy Investments Ltd.) and INX Limited (“**INX**”).

This is the initial report filed under the early warning reporting rules by the Acquiror with respect to the Resulting Issuer.
